The Pima Natural Resource Conservation District is a local unit of Arizona state government. The District encompasses 2.14 million acres in eastern Pima County, Arizona. The District provides habitat for 22 listed threatened and endangered species, including thousands of acres of designated critical habitat adjacent to our porous and insecure Mexican border.

The Pima NRCD is a member organization of the National Association of Conservation Districts (NACD). This morning, NACD President Brent Van Dyke sent you a letter on behalf of its members, including the Pima NRCD.

Due to competing time commitments over the past week, the Pima NRCD has been unable to adequately review and internally discuss the fine details of the package of bills introduced by the Congressional Western Caucus. The bills seek to remedy some of the many shortcomings of the ESA in its current form. The bills, if passed, would represent a sea change in this landmark environmental law and therefore deserve a great deal of public review and discussion before they become law for decades to come.

That said, the letter the Mr. Van Dyke sent on our behalf faithfully represents our district's concerns.

We greatly appreciate the efforts of the Congressional Western Caucus to modernize the ESA to provide opportunities and incentives for voluntary conservation while relieving innocent and well-meaning citizens from the negative unintended consequences experienced in the past. We appreciate your common sense efforts to relieve the U.S. Fish and Wildlife Service from frivolous petitions designed to overwhelm and thereby politically control the agency's decisions.

Dear Chairman Gosar:

The National Association of Conservation Districts (NACD) represents America's 3,000 conservation districts and the 17,000 locally-elected men and women who serve on their governing boards. Conservation districts are local units of government established under state law to carry out natural resource management programs at the local level. Districts work with millions of cooperating landowners and operators to help them manage and protect land and water resources on all private lands and many public lands in the United States.

The Endangered Species Act (ESA) must be modernized, and voluntary conservation plays an important role in achieving this. The ESA legislative package the Congressional Western Caucus has announced this week emphasizes the needs of communities impacted by listings and focuses on scientific consensus rather than a politically-driven agenda. NACD supports this package requiring the federal government to work with all public and private partners, including conservation districts and tribal governments, involved in managing the critical habitat for listed species.

NACD appreciates members of the House wanting to develop programs to provide tax incentives to landowners to encourage species recovery on private lands. The importance of codifying safe harbor agreements and candidate conservation agreement with assurances will directly benefit listed species and private landowners.

We strongly believe that local decision-making, rather than litigation, is the best way to address environmental challenges and achieve positive results for our threatened species.

NACD thanks you for your consideration and introduction of this important legislative package.
